- Order № RD-16-183 / 25.02.2016 on the elimination of OCL on boulevard. "Hristo Botev" from Central Station to Komatevski junction / intersection involving Central Station /;
- Order № RD-16-184 / 25.02.2016 on the elimination of OCL on "Septemvri 6th" blvd. - from the courthouse - 177 "Septemvri 6th" to the "Shahbazyan" square entirely within the intersection of Bath "Old", "Tsar Boris III" blvd. between "Maritsa - South" blvd. and tunnel-North;
- Order № RD-16-185 / 25.02.2016 on the elimination of OCL on "Vasil Aprilov" blvd. from the "Peshtersko Shosse" blvd. to "Septemvri 6th" blvd.;
- Order № RD-16-186 / 25.02.2016 on the elimination of OCL on "Hristo Botev" blvd. in the area between Freight yard and "Iztochen" blvd. and from Freight yard to Central Station.

The total value of Construction contract № 35 / 08.28.2016, in the register in Region "Central" with "Avis Engineering" company is in the amount of 298 993.84 lev incl. VAT.

As required by the Contract № 35 / 08.28.2016, the deadline for implementation runs in five calendar days after its signing and has set period of order execution thirty-three calendar days. The Contractor performed the contract on time and completed construction works were adopted with Act. 19 on 29/08/2016, the

"Avis Engineering" company qualitative and timely executed the terms of preparation and coordination of design documentation for the sites. The drafts part PHS - Anchoring are transmitted to the Client in 3 / three / copies, and is delivered PCWM project and projects for "Temporary Organization of the traffic" of each section of the OCL (overhead contact line). The project documentation has passed in coordinating with all necessary steps.

Upon execution of construction works (CAW) assigned with Contract № 35 / 28.08.2016, the Contractor performed strictly and with quality its obligations. Transceivers Protocols have been regularly prepared, accompanied by inventory of submitted separately, dismantled from sites materials and equipment and weighing receipts. No undone and unfinished sub-sections under the construction contract. Activities for assembly and disassembly of the OCL (overhead contact line) according to the design documentation and requirements of the Client:

Dismantling of the contact wire - 25 192 km .; Supply and installation of a firm anchoring of CW - 82 pcs.; Dismantling of a fixing rope 30 m - 216 pcs.; Dismantling of bearing rope 30 m - 124 pcs.; Dismantling of anchoring arrow - 29 pcs .; Disassembling the console CW - 112 pcs .; Disassembling of console with rails bend set - 62 pcs. and many others.
